Students may provide proof of financial capability by documenting personal financial holdings, or by sponsorship. If proving financial capability by sponsorship, the student's sponsors must provide proof of financial capability, and must guarantee full financial responsibility to support the student's attendance throughout the duration of their enrollment at McHenry County College. Failure to fulfill financial obligations may result in loss of the student's F-1 visa status.

2024-2025 International Cost of Attendance (COA) for 12 credit hours*

U.S. federal immigration regulations require that international applicants provide proof of adequate financial resources to live and study in the U.S. on a full-time basis (12 or more credit hours per semester) for at least one full academic year (fall and spring semesters/9 months).

International students are required to have sufficient funds to meet all expenses throughout the duration of their enrollment at MCC. Failure to fulfill tuition obligations may result in loss of the student's F-1 visa status.

Students holding F-1 student visa status are allowed to work a maximum of 20 hours per week on campus during fall/spring semesters. Off campus employment may be requested after one academic year if the student is maintaining lawful F-1 visa status and is in good academic standing. Any off-campus employment must be authorized by MCC Admissions and USCIS, and must be directly related to the student's field of study indicated on the student's I-20. The student should not view employment as a significant source of financial support while attending MCC.

The international tuition rate for 2024-2025 is \$462.73 per credit hour.
