Opening Days Recap

On Thursday, August 15, nearly 300 new students gathered at MCC to meet one another and create new connections, walk their schedule before the first day of classes, and talk with MCC staff and faculty. This event is a new student's first opportunity to experience MCC's sense of community and develop a connection with the College and future classmates before the semester begins. In addition to student engagement, faculty also experienced a Fall Faculty Development Day, which included connection sessions by pathway with new

students, breakout sessions with other faculty members, and a strategic planning workshop with Dr. Gabbard. On Friday, August 16, non-faculty employees shared in a morning of connection and inspiration to prepare for the new semester.

2024 Community Block Party Recap

Over 200 individuals celebrated MCC together for the College's second-annual block party. Students, alumni, friends, and employees shared in community, food, and music at Sew Hop'd Brewery in Huntley. The Center for Agrarian Learning (CAL) Student Farm showcased fresh produce, and the Community Enrichment Center's Kids & College program hosted an activity station. The event raised over \$7,000 toward student scholarships and support.

Enhanced MCC Café Hours and Services

The MCC Café has expanded its services for fall to ensure our on-campus community has regular access to nourishment. Effective Monday, August 19, the café extended its hours of operation to provide more availability to students and faculty who are on campus later in the day:

Monday–Thursday: 7:30 a.m.–4:30 p.m.

Friday: 7:30 a.m. – 1 p.m.

In addition to extended hours, 24-hour grab-and-go options are also available, offering nearly all food options that are available during operating hours. Over 160 food items are available for after-hours purchasing, including several daily entrée items. Microwaves are also available in the vicinity for (re)heating food. Finally, this fall, the MCC Café will be:

• Installing new kiosk with a self-service checkout option

• Adding campus vending in the Black Box Theatre Lobby, which will offer TV dinners, soups, and other options, including water service and a microwave

The College will continue to identify ways to expand food access on campus, including regularly asking for feedback. During the first few weeks of the semester, students will be asked to complete a short survey with their input via QR Code located on café signage.

University Center Grand Opening and Ribbon Cutting Recap

Over 150 guests attended the University Center at MCC's grand opening and ribbon cutting on August 1. The celebratory event featured public comments from Dr. Gabbard and friend of the College, Tom Liebman, as well as community conversation and self-guided tours throughout the College's new facility in Woodstock. Leadership from all four university partners were in attendance, as well as donors and city and county officials.
