Spring 2025 Commencement Recap

The College recognized 792 graduates at its Commencement Ceremony on Saturday, May 17. Of those graduating, a record-number 292 individuals participated in the event, with the MCC Gym and three viewing areas filled to capacity with friends, family, and other supporters. Of these graduates, over 60 individuals earned their Dual Degree through MCC's partnership with Harvard Community School District 50, Woodstock District 200, and Huntley Community School District 158. The Spring 2025 Commencement Ceremony highlighted student speaker, Ramona Henderson, and concluded with a faculty charge from ICCTA 2025 Faculty of the Year recipient, Dr. Paige Lush. Prior to the ceremony, MCC held its annual Nurses' Pinning Ceremony. A hearty congratulations and best wishes to all MCC spring graduates.

Progress on Campus Renovations

Administrator Session on Communication and Conflict

On Wednesday, March 14, MCC administrators participated in an all-day development session to learn tips and tools for how to work through difficult conversations and conflict. Facilitated by the Center for Conflict

Resolution in Chicago, this immersive and hands-on discussion also included a section on de-escalation strategies. Feedback from participants was positive, and administrators will continue sharing feedback about how they are applying what was learned in their daily interactions.

MCC Student Art Awards

The annual MCC Student Art Exhibit, showcasing work from students enrolled in credit art courses from the fall and spring semesters, is on exhibit in Epping Gallery, artspace144, and the Student Galleries. A total of 134 MCC students entered 179 artworks, of which 43 pieces were chosen by MCC faculty for exhibition. The MCC Art & Design Department hosted an Awards Reception on Thursday, May 8. It was fantastic to celebrate our outstanding art students alongside their friends and families. Over 170 people came out to support these talented students. The exhibit will be on display through June 5.
