If there was availability of a FOIA form, I would have been happy to fill it out when I visited the campus police office last Friday, September 24th.</p> <p>I am trying to understand why campus police would be called in an event where a student is in an office asking for physical forms to file for financial aid, only to be asked if I was visually or hearing impaired, in order to receive any assistance.</p> <p>I witnessed the clerk write out my student ID#, my first name, and a note that said, "give to police" then hand it to a campus police officer. This frightened me. I was told there "is no issue" when I asked to speak with campus police; when I asked them what was going on, they said "that is what we are trying to figure out"- which only added up to more confusion. I was then asked "if I had everything I needed" while it was suggested that I vacate the premises.</p> <p>I feel insulted, fearful, and discriminated against after being escorted out of the financial aid office by campus police without receiving the help I was seeking.
