And the direct contact information of the responsible public employee who has the authority to make decisions regarding the current "Sole Source Procurement Contract" for the purchase of energy.</li> </ul> <p>I understand that the Act permits a public body to charge a reasonable copying fee not to exceed the actual cost of reproduction and not including the costs of any search or review of the records. 5 ILCS 140/6.
